

NENT Group counts in 'Two Sisters' for next original production

- 'Two Sisters' based on Hannah Widell and Amanda Schulman's bestselling novels
- Widell and Schulman are two of Sweden's most high-profile media personalities

The next Viaplay Original from Nordic Entertainment Group (NENT Group), the Nordic region's leading streaming company, will be the Swedish drama series 'Two Sisters'. The eight-part show is based on the bestselling novels by Swedish celebrities Hannah Widell and Amanda Schulman and is produced by Yellow Bird ('Millennium'; NENT Group's 'The Truth Will Out'). 'Two Sisters' will premiere exclusively on NENT Group's Viaplay streaming service across the Nordic and Baltic regions in 2021.
